Booking Terms & Conditions

Please read the following terms and conditions carefully. You must not accept any booking unless you understand and agree with the following terms and conditions.

Prices - All prices are subject to availability and can be withdrawn or varied without notice until paid in full. Prices are usually quoted in Australian Dollars but may be subject to exchange rates fluctuations beyond our control. All deposits are required to be paid before bookings will be processed. Full payment required minimum 60 days before departure – this may be earlier subject to individual operators' policies. Some air tickets & specials may be instant purchase. If bookings are made inside of 60 days; then full payment required immediately.

Changes to Travel Documents - Travel documents include (without limitation) airline tickets, hotel vouchers, tour vouchers or any other document (whether in electronic form or otherwise) used to confirm an arrangement with a service provider. Travel documents may be subject to certain conditions and/or restrictions including (without limitation) being non-refundable, non-date-changeable and subject to cancellation and/or amendment fees. All travel documents are non-transferable. All airline tickets must be issued in the name of the passport/photo identity holder, some carriers will deny carriage if the name varies and the booking may be cancelled. **It is your responsibility to collect, or ensure you have received, all travel documents from us prior to travel** Please contact your consultant minimum 2 weeks prior to departure if you have not received your documents.

Cancellations- The Perfect Wave is unable to provide a refund to you until we receive the funds from the relevant supplier. This may take up to twelve weeks (longer for lost tickets). Cancellation of bookings will incur charges and deposits are non refundable. Fees will also apply where a booking is changed or tickets are reissued.
